- The Winter Transportation Building still needs to be connected to the EMS building.
- Paul mentioned that he has ordered guard rails to install at the edge of the blacktop in front of the solar panels. Paul thinks fencing should be considered at some point.

8. EMS heating system update

Paul got pricing to hook up the existing in-floor tubing to a 90% + efficiency boiler. This cost would be \$24,000 which included sizing the boiler for an addition to the EMS building if that happens.
