## V. New Business

#### a. Rental Ordinance

Lisa Potswald, Town Administrator attended a meeting with the Madeline Island Sanitary District. Her notes from the meeting were distributed to the members of this Commission as well a brief correspondence with Josh Rowley, Ashland County Zoning Administrator. The findings are in concert with the recommendations by the TPC recently forwarded to the Town Board for consideration of short and long-term rentals of Camping Units. It is the consensus of the TPC to place this item on the next Town Board agenda in *order* to clarify whether a "Camping Unit" may or may not be rented.

## b. Ordinance Review at County Level

The Town Board has approved the Zoning changes related to ACT 67 and Section 5 Signs. These changes will be forwarded to the Ashland County Zoning Department for review by the Zoning Administrator, Zoning Board and subsequently the County Board. These will also be reviewed by our town's attorney. Affidavits of posting, publishing and dates of hearings will accompany this text change.

#### c. Fire Numbers

The ZA had a break in during his absence and the theft involved the latest data work on fire numbers. The County GIS Coordinator, Brittany Goudos-Weisbecker, is providing the ZA with replacement maps this week. Chair Soucek has volunteered to aid in updating the data entries next Tuesday at 10AM. The next meeting with the County on this issue is Thursday, March 14<sup>th</sup>.

# d. Zoning Brochure Development

Chair Soucek and the ZA will address this during the fire number update and have a draft proposal for the TPC at the next meeting.

## e. Posting of Zoning Signs

The Town Board has approved the installation of the Zoning signs. The TPC recommends placement of these on Main Street. North and South of the ferry dock. The ZA will coordinate the installation of these signs with the Public Works Department.
