
We are currently working with the DOT for putting an intoxilzer machine on the island. Officers who have not had the training to operate this machine will be going in the coming months.

Last month, we were talking about parking, and we have put quite a bit on the department FaceBook Page, since then, we towed two vehicles out of Lot W. We had two others slated to be towed but were unable to with the truck the tow company brought over, since then, those vehicles finally moved. Of the vehicles towed, one vehicle is being claimed, letters to one remain unanswered. After 30 days of being in impound, one will be deemed abandoned according to Wi Statute, and be slated for crushing.


By the time you receive this report I will have attended Legislative Day at the Wisconsin State Capital with Chiefs and Sheriffs from across the state. My focus is the transportation and availability of mental health services in northern Wisconsin. As of now, if we were to take someone in on a commitment, all local agencies take the person to Memorial Medical Center in Ashland, from there, we have been having to transport people to Oshkosh, La Crosse and Madison on a regular basis as there are not enough beds available in northern Wisconsin. Every commitment call costs every agency in northern Wisconsin a lot of overtime and transportation costs, and unlike other agencies who can leave and have the county cover, we still must have someone on the island. Not to mention that it really is not fair for the person being transported to have to be transported that far in their mental state. Depending on the person being transported, that could be two officers, and a vehicle gone for a day. We need services closer to those of us in Northern Wisconsin. There is a group of us who started the conversation, hoping to continue it further and get some sort of state aid.


Speaking of training, Officer Rahlf and Sgt Rossberger are now certified to run an intox machine, we are just waiting for our computer guy to install a new internet port and the state will be setting us up with our own intox machine. This brings us up to three total officers that are certified in the usage.

I attended Legislative days in Madison in April, several Chiefs and Sheriffs spoke with many legislators from across the state in one-on-one conversation. I teamed up with Chief Roux (Rice Lake) and Chief Alexander (Superior) to speak with legislators including our local ones as we were the only ones representing Northwest Wisconsin. Topics covered were mental health, recruitment and retainment officers, a need for an increase in pay for District Attorneys across the state as well as an increase in training funds from the state. The update that I had heard was that it is being recommended to double the current training funds given to departments from \$160 an officer to \$320 an officer. We certainly hope that is going to happen as training costs keep going up.




As some of you may have heard, we are losing one of our officers, it will be down to three of us covering the island and having to double up during important weekends. We have some guys on our part time roster that will be trying to help where they can. However, I would expect to have a bit of overtime this summer. I have contacted the Sheriff's Office, they are down three deputies, and one more retiring in August. They will not be able to help much if at all. I have already posted for a part time officer on WILENET (Wisconsin Law Enforcement Network) which is run by the DOJ, but there are already quite a few postings on there, and my fellow chiefs are not getting any applications for part time.

The state installed an Intoximeter machine at the fire hall. We will now be able to test 1st offense Operating a Motor Vehicle While Intoxicated arrests, which also includes the not a drop law for all persons under 21, without having to go to the mainland, providing they have a responsible party to take custody of them. The DA's office requests a blood test for 2nd and subsequent offenses. The only challenge will be finding someone that has not been drinking to take custody.

The Madeline Island Marathon went off without any incident, we received three deputies from the Ashland County Sheriff's office with help with traffic control as well as two wardens from GLIFWC. With the upcoming In Line Skate Race, we have Two Deputies coming from the Ashland County Sheriffs office and three wardens from GLIFWC.



Incident Frequency by TYPE (Top 33 of 33 Shown) (Using DATE RECD)







Karl Williams is now at the academy, and is doing well, we look forward to being able to use him full time in the near future.


By the time you read this, our new squad should be in use on the island. There was a long wait with delays due to equipment not coming in. As I type this, Big Water is in the final stages of equipping it.



First for our calls that stand out. There was a burglary that occurred on a night there was no island officer on duty, however it was discovered and reported to the on-duty island officer. This case is still being investigated, if anyone has any information, please contact the La Pointe Police Department.

There were two calls that were held over for island officer to return, one involved a firearm theft that should not have been held over at all. Our officer who got the call was able to retrieve the firearm over in Washburn, there are details in this call I can not disclose, but this is a call that should have been handled immediately by the County, we are lucky with the outcome we had. The Washburn Police Department aided us in retrieving the firearm. The other call was a person who called in that they thought they left their oven on.

Another call the county passed over this month was a welfare check and had the ambulance check on it. This welfare check had a good outcome, but I wonder what would have happened if the ambulance walked into a crime scene as all unwitnessed deaths are considered crime scenes until they are not.

In February, I will be heading to training with the Wisconsin Police Leadership Foundation, which is the annual training I attend.


Speaking of training, the rest of the department that needs training will be heading to training between now and June 30th.


